While it is preferred that the biography be sent electronically, we will accept typewritten (in Microsoft Word format). The Hall of Fame Committee will use the text of the biography (no more than 350 words) which will be given to the Board of Directors of the Badger Foundation to determine whose name will be placed on the ballot. Once the candidates are determined, the same biography will be part of the Hall of Fame packet provided to the voting pool. 5. The Hall of Fame Chair, and one committee member, will interview the candidate, or the nominator (when the candidate is nominated posthumously) in person or by phone to ensure the accuracy of the application form and biography.

6. Elected candidates will be responsible for providing an 11x14 head shot photograph (portrait orientation) for display on the “Wall of Fame” in Tucson High’s Main Building. Once received, the photograph becomes property of the Tucson High Badger Foundation.
